(57) **CLAIM**

I claim the ornamental design for the “prescription greetings decal,” as shown.

DESCRIPTION

FIG. 1 is a front elevational view of the prescription greetings decal showing my new design, the decal having no substantial thickness.

FIG. 2 is a front elevational view of an upper body garment having the prescription greetings decal of the invention applied thereon.

FIG. 3 is a back elevational view of the upper body garment shown in FIG. 2.

FIG. 4 is a front elevational view of another upper body garment.

FIG. 5 is a back elevational view of the upper body garment of FIG. 4 having the prescription greetings decal of the invention applied thereon.

FIG. 6 is front elevational view of a cap having the prescription greetings decal of the present invention applied thereon.

FIG. 7 is a back elevational view of the cap of FIG. 6.

FIG. 8 is an elevational side view of a mug having the prescription greetings decal of the invention applied thereon.

FIG. 9 is an opposite elevational side view of the mug of FIG. 8.

FIG. 10 is an elevational side view of a wine glass having the prescription greetings decal of the invention applied thereon; and,

FIG. 11 is an opposite side elevational side view of the wine glass shown in FIG. 10.

The “RX GREETINGS” logo visible in the several views is a trademark which represents PRESCRIPTION GREETINGS owned by Mark P. Boulos. Material in the several views shown in broken lines illustrates variable environmental material associated together with material shown in solid, and forms no part of the claimed design.

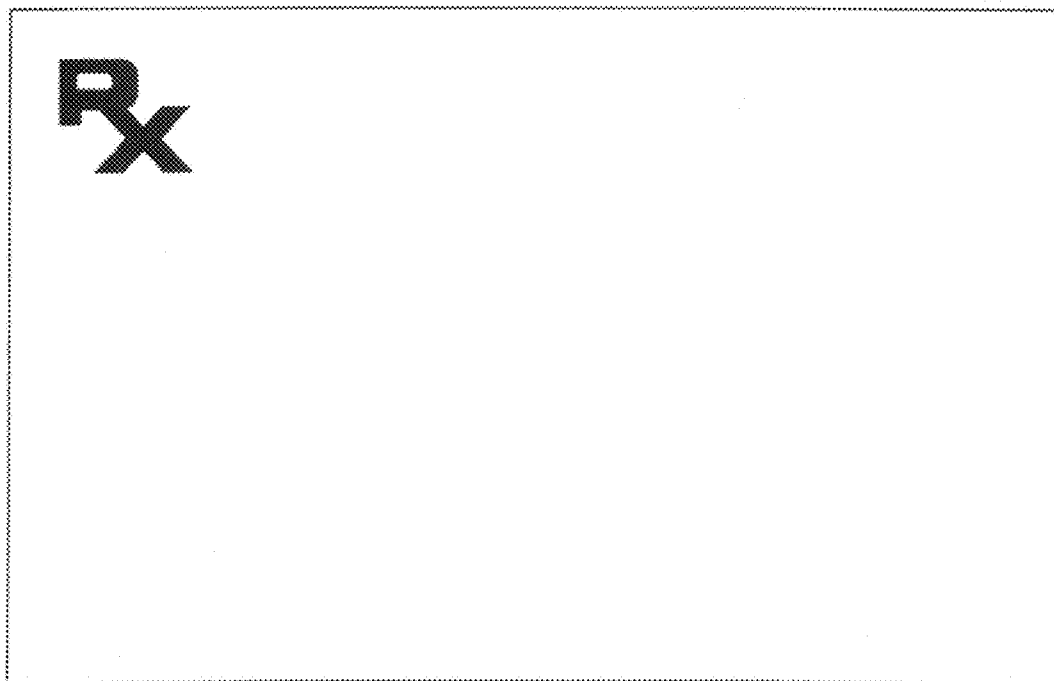
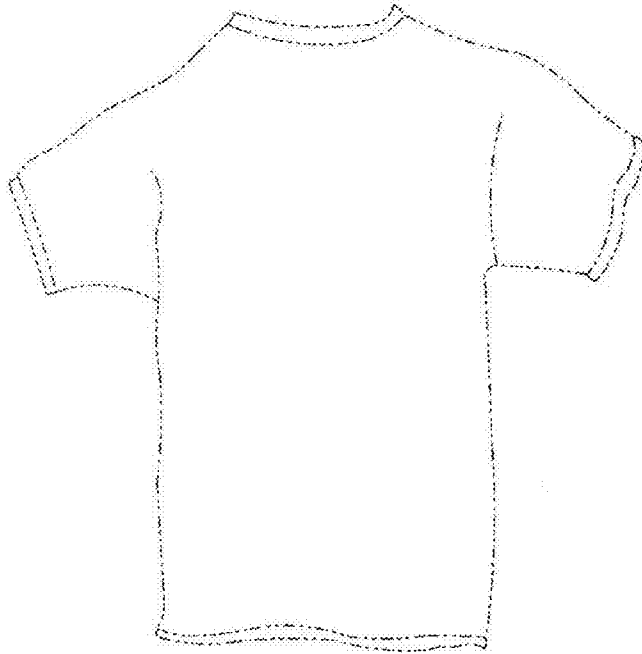

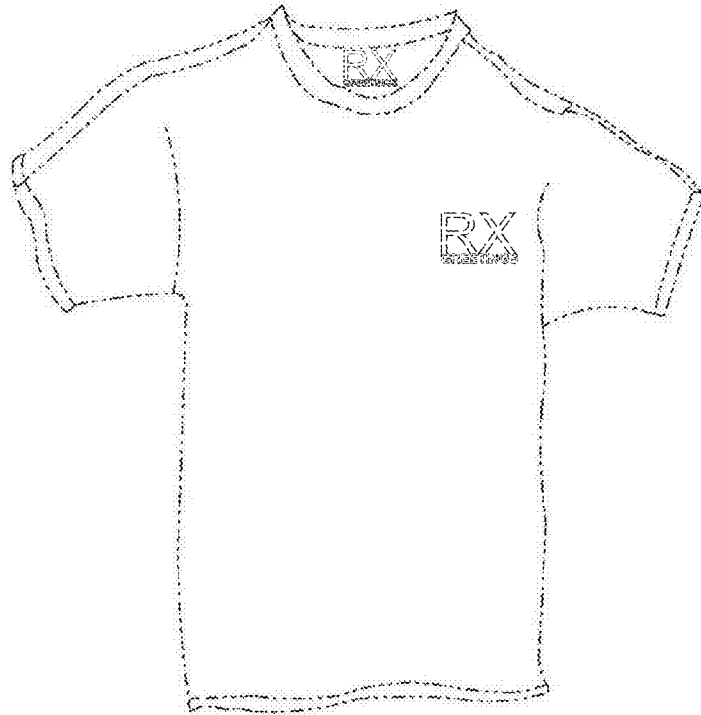

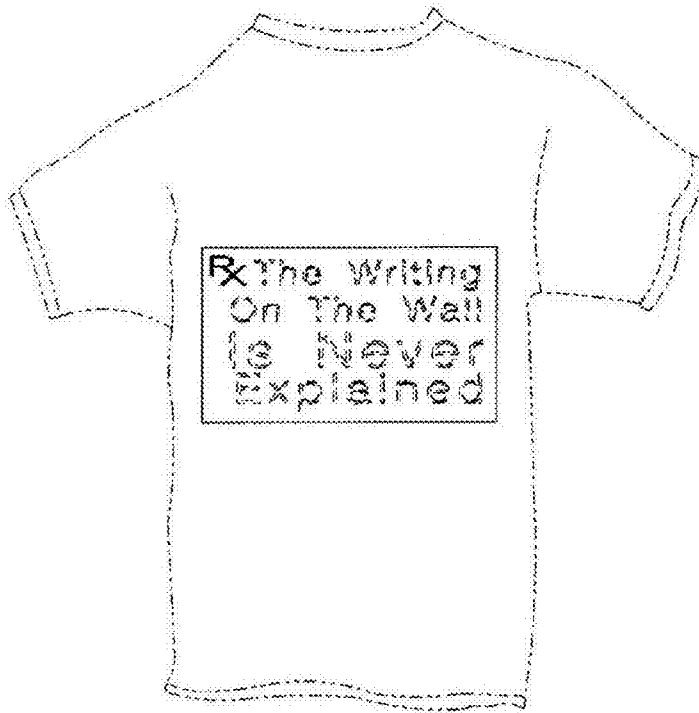

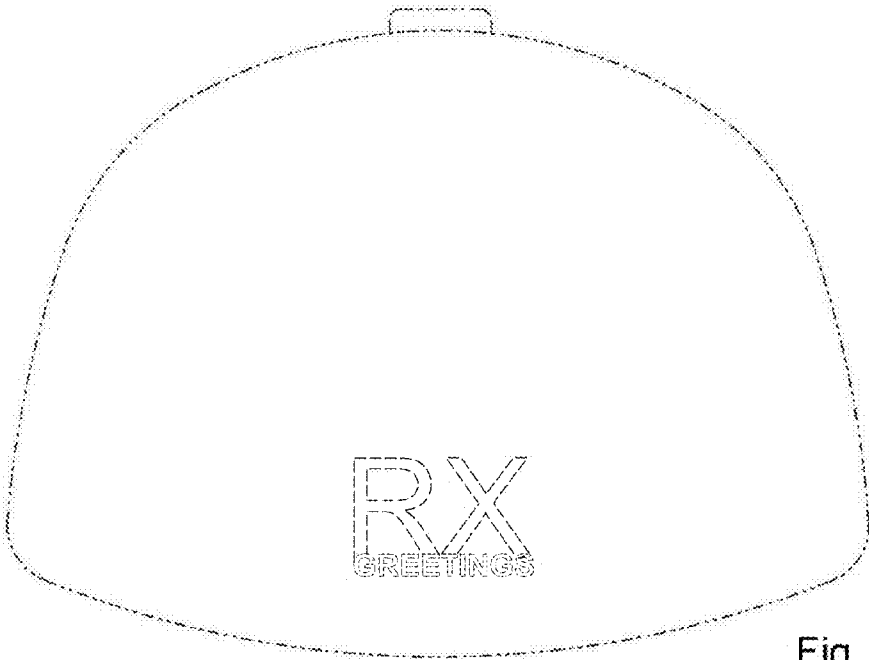
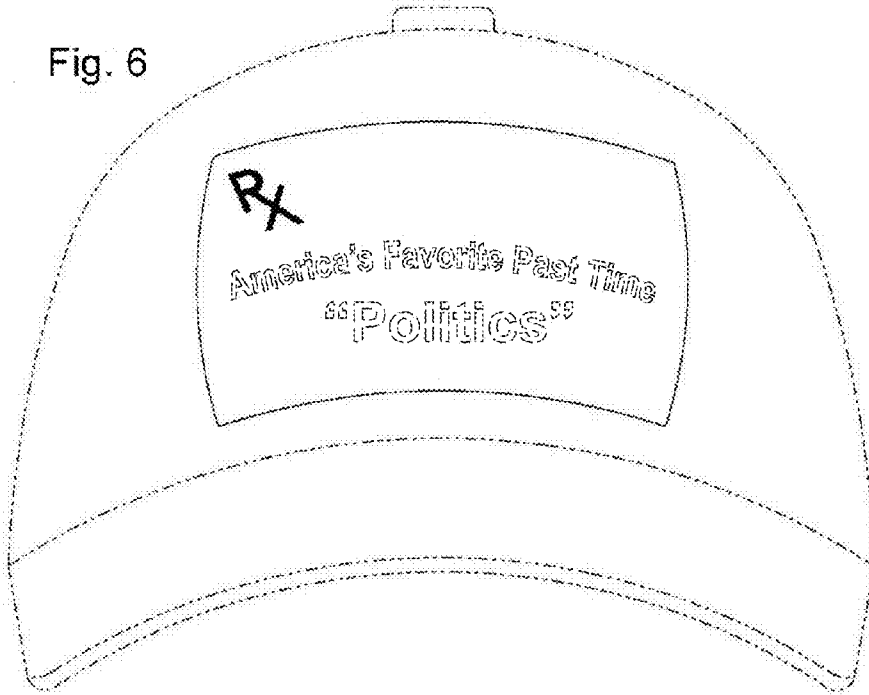

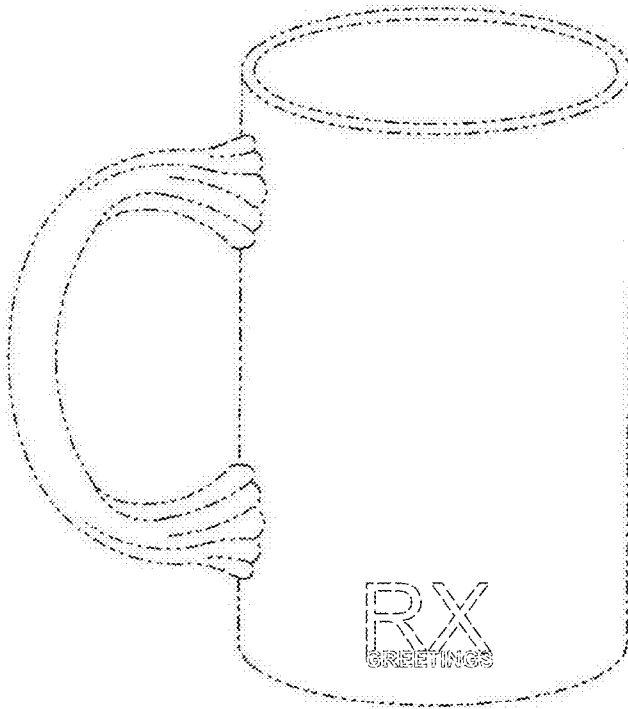
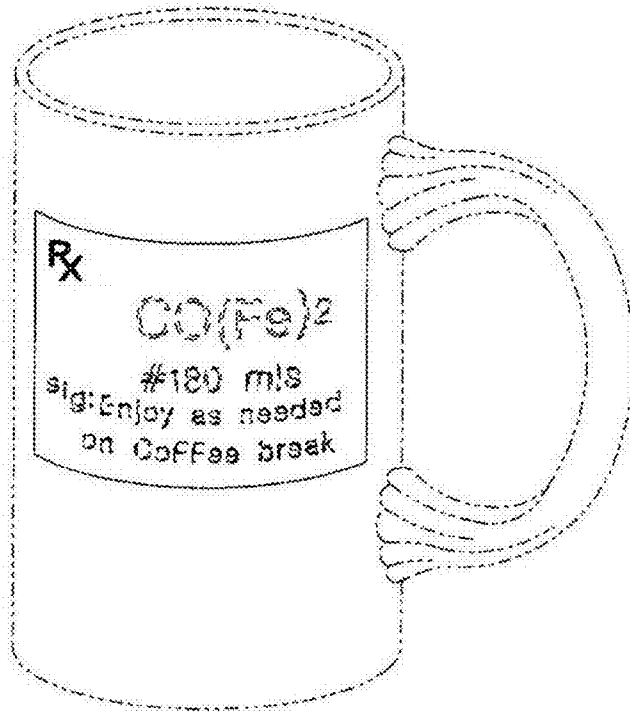

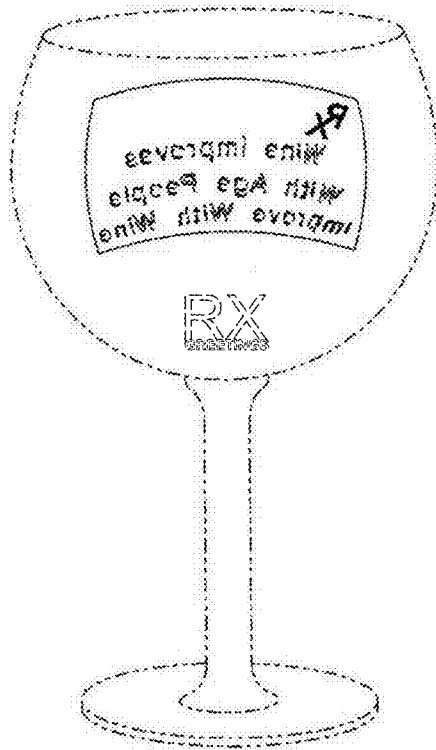
